1. Interpretation and Definitions

a. Interpretations

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

b. Definition

For the purposes of this End-User License Agreement:

- Affiliate means an entity that controls, is controlled by or is under common control with a party, where
 "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to
 vote for election of directors or other managing authority.
- Account means a unique account created for You to access our Service or parts of our Service.
- Company (referred to as either "the Company", "We", "Us" or "Our" in this Disclaimer) refers to timeNough Europe Inc. (SARL-S), 223 rue de Cessange, L-1321 Luxembourg.
- Country refers to: Luxembourg
- Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to timeNough Europe Inc. (SARL-S), 223 rue de Cessange, L-1321 Luxembourg.
- Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- Free Trial refers to a limited period of time that may be free when purchasing a Subscription.
- Service refers to the Website.
- Subscriptions refer to the services or access to the Service offered on a subscription basis by the Company to You.

2. Acknowledgment

These are the Terms and Conditions governing the use of this Service and the agreement that operates between You and the Company. These Terms and Conditions set out the rights and obligations of all users regarding the use of the Service.

Your access to and use of the Service is conditioned on Your acceptance of and compliance with these Terms and Conditions. These Terms and Conditions apply to all visitors, users and others who access or use the Service.
